**HURRICANE HAUL-OUT RESERVATION CONTRACT**  
**HURRICANE CONTINGENCY ACTION PLAN & FEE SCHEDULE**  
**HURRICANE ACTION PROCEDURES**

Notification & Commitment:

The facility, Sea Love Boat Works, Inc., will initiate the Contingency Plan as it is determined by the inclusion of the region when it is in the strike probability cone, provided by the weather service. Initiation is expected to be at least 96 hours before expected landfall.

Inquiries by contract holders will be taken in the order they are received. Time & Date of inquiry call will be noted and early haul out commitments will be recorded.

The haul out schedule will be determined as contracted vessels arrive that have previously made their haul out commitment by phone and/or confirmed email, in coordination with boatyard management.

Please be **prepared & patient** as everyone will be hauled in a timely and safe matter.

Boat Owner or designated agent is responsible for securing the following item(s) prior to leaving the boat yard:

- Eisenglass, Canvas, Cushions
- Antennae, Outriggers
- Hatches, Windows, Doors
- Tenders, Life rafts, All on Deck Items.
- Turn off all power (AC/DC) systems.

Sea Love Boat Works, Inc. is not responsible for any damage to secured or unsecured items or damage to vessel(s) as a result of storm, storm surge, hurricane impact winds, rain or any other Acts of God.

All Contracted or Emergency Hurricane Haul Out Customers must provide, or have on file; Sea Love Boat Works, Inc. with and Insurance Certificate of Marine Liability, with limits of not less than \$500,000 and a deductible of not more than \$10,000 per occurrence, naming Sea Love Boat Works, Inc. and Blue Water Realty Advisors, LLC. as the Certificate Holder and must have Sea Love Boat Works, Inc. and Blue Water Realty Advisors, LLC. listed as Additionally insured, prior to vessel being hauled.

**Pursuant to Florida statue 327.59:** Sea Love Boat Works hereby informs you that in the event you fail to remove your vessel from the marina promptly (timeframe to be determined between the marina owner or manager, and the vessel owner) after issuance of a tropical storm or hurricane watch for Volusia County, Florida, under Florida law, that Sea Love Boat Works, Inc. is authorized but, not obligated to remove your vessel, from its slip, or take any and all other reasonable actions deemed appropriate by Sea Love Boat Works, Inc management, employees or agents in order to better secure your vessel and to protect marina property, private property, and the environment. You are further notified that you will be charged an emergency hurricane haul out fee for any such action, see hurricane haul-out schedule.

Sea Love Boat Works and Marina, it's owner, manager, employee, or agent shall not be held liable for any damage incurred to a vessel from storms or hurricanes either in wet slips or up-land storage and is held harmless as a result of such actions. The Boat Owner is responsible for any and all damages incurred to the Marina common areas and real or personal property adjacent or connecting to the Marina, as a result of Owner's failure to comply to this provision.
